



# Health & Safety Plan for Pandemic Phased Reopening

revised September 09, 2020

The Circle School plans to reopen for students and staff on **Wednesday, August 26, 2020, as published in the school calendar**. This Health & Safety Plan outlines the pandemic-related precautions and practices that will guide The Circle School's reopening and operations during the pandemic. The Plan and the school's practices may be revised by the school from time to time, based on experience and evolving guidance from external authorities.

School operations will be informed by Governor Wolf's online [Process to Reopen Pennsylvania](#) in its current form ("last updated July 1, 2020") and as revised from time to time; by the Pennsylvania Department of Education's "Preliminary Guidance for Phased Reopening of Pre-K to 12 Schools (June 3, 2020; Version 1)" (PDF downloaded from PDE website July 1, 2020); and by CDC guidelines.

State administration has categorized reopening into three broad phases: red, yellow, and green. These designations signal how counties and/or regions may ease restrictions on school, work, congregate settings, and social interactions:

- **Red Phase:** Schools remain closed for in-person activities. Large social gatherings are prohibited.
- **Yellow Phase:** Schools may conduct in-person activities following Department of Education guidance. Social gatherings of up to 25 are permitted, with social distancing.
- **Green Phase:** Schools may conduct in-person activities following CDC and state guidance. Larger social gatherings are permitted, with social distancing.

While in Yellow Phase, the school will apply the following Yellow Phase measures. While in Green Phase, the school will apply the following Green Phase measures unless, because of local conditions, School Meeting determines to follow the more stringent Yellow Phase measures.

## I. Cleaning, Sanitizing, Disinfecting, and Ventilation
